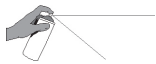

## PG&E Defends Inspection Plan

PG&E is vigorously defending the role it played in a lobbying campaign which persuaded federal regulators to allow "direct assessment" of its pipes, a technique which saved them oodles of money if you don't count loss of life.

"I think all the direct assessment techniques work very well," stated Kirk Johnson, PG&E vice president in charge of transmission pipelines, "except for in San Bruno."

Johnson acknowledged that direct assessment techniques saved PG&E millions in system upgrades that would have been necessary to accommodate hydrostatic or ultrasonic assessments, but asserted that "smart pig" ultrasonic testing has its own, unknown costs.

"Smart pigs are hard to come by," stated Johnson. "We're not entirely sure that even very smart pigs would be welcome in some of the communities we serve."

Ratepayers wary of replicating San Bruno's explosion, which killed eight people and destroyed 37 homes, expressed enthusiasm for pigs.

"We're piggable," nodded one ratepayer with enthusiasm. "We've put up with dumb pigs for a long time. The smart ones should be no problem."

dent. “Uncle George conked out on the dining room floor the other night, and we didn’t have the heart to move him.”

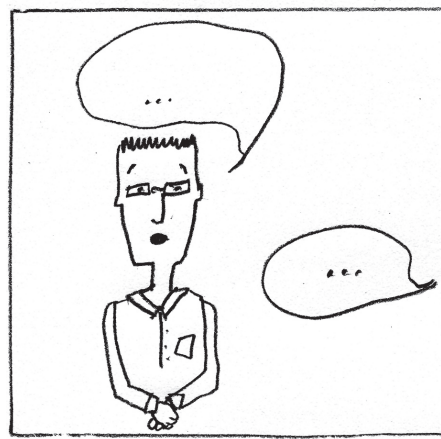
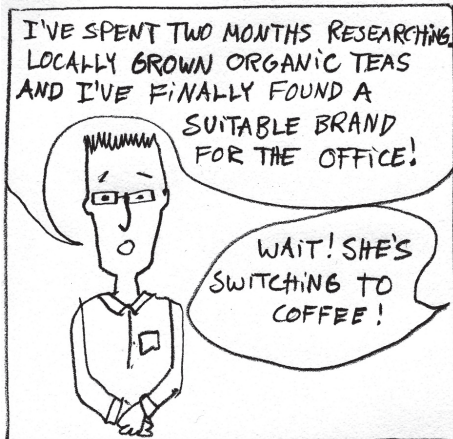

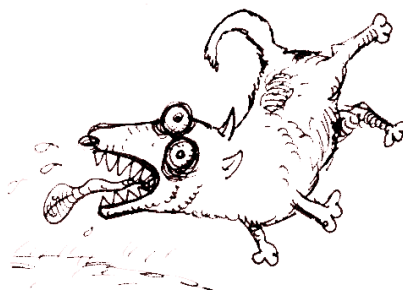
